Kristin Boyes will begin her first season as head coach of the North Central Missouri College Lady Pirates Fastpitch Softball team in the fall of 2011. Coach Boyes comes to NCMC after four years as head softball coach at Minnesota State University-Moorhead, a NCAA Division II school located in Moorhead, MN.

Coach Boyes' history also includes a two year stint as a graduate assistant coach at Southwest Minnesota State University and one year as an assistant coach at Dodge City High School in Kansas.

Her playing career includes two seasons at Dodge City Community College, where she was an All-Region catcher and helped lead the Conquistadors to the NJCAA National Tournament in 2002. Coach Boyes also played two years at Emporia State University, graduating in 2004 with a degree in Physical Education.

Purpose: The NCMC softball camp is designed to help improve the softball knowledge and skills of each of its campers. The camp features the NCMC coaching staff and players working to develop fundamentals and individual skill of the participants. Campers will have the opportunity to engage in competitive situations with and against students from other schools.

Location: The camp will take place on the campus of North Central Missouri College in Trenton.

Participation: The camp is open to girls entering 5-12 grades for the 2011-2012 school year. Campers will be divided into groups according to age and skill level.

Costs: The cost for the camp will be \$215, which includes meals, housing and a camp t shirt. For those choosing to not stay overnight, the cost of the camp will be \$185 and will include the noon and evening meal each day, as well as a camp t-shirt.

Roommate Preferences: To ensure roommate preferences, make sure to include your choice on the registration form in this brochure.

Typical Day: A typical day will include 2 - 3 softball work sessions, running 1 ½ - 2 hours in length. Meals and recreation activities are included.

Check-In: Registration will be Monday, June 6, 2011 from 9 am until 11 am in the front lobby of Ellsworth Hall on the NCMC campus.

Departure: Campers will be released at 3:30 pm on Wednesday, June 8, 2011.

Items to Bring: Sheets, pillow, pillowcase, blanket, towels, soap, shampoo, plenty of practice apparel, softball shoes, tennis shoes (for indoor use), ball glove, batting glove (if needed), bat (if you have a favorite), and spending money if you want snacks, etc. If not, NCMC will furnish it. If you want to swim (weather permitting) bring your swimsuit. We have a great pool- pizza party one evening at the camp.

Positional Work: Players will receive instructions on their individual positions. For example, pitchers will receive special pitching instructions, catchers will receive special catching instructions, etc.

Registration and Cancellation Policy

- Enclose a \$100 deposit or the entire camp fee with your application.
- If you send the deposit only, the balance of the payment will be due upon arrival and check-in.
- No refunds unless a camper has a doctor's signed medical excuse.
