

JUMP-START RN TO BSN DUAL ENROLLMENT GRANT PROGRAM: Chamberlain University School of Nursing



Get an early start on your Bachelor of Science in Nursing (BSN) degree with two tuition-free college courses

HOW IT WORKS:

- All associate degree in nursing (ADN) and diploma program students are now eligible for a new dual enrollment program. Eligible students receive two tuition-free, fully online college courses toward the pursuit of a Bachelor of Science in Nursing (BSN) degree from Chamberlain University College of Nursing.
 - The two courses equal seven credit hours towards your BSN degree at Chamberlain
 - Students must start at least one of the two tuition-free courses before the conferral of their ADN degree or diploma
 - Courses are 100% online allowing you to participate around your schedule
 - Tuition-free courses are made possible through a grant provided by Chamberlain University

NR-305: HEALTH ASSESSMENT FOR THE PRACTICING RN

4 credits

Build on existing nursing assessment knowledge and explore current and innovative techniques for assessing an individual's physical, psychosocial, cultural and spiritual needs. Use assessment findings for clinical decision making and the creation of individualized patient teaching plans.

NR-351: TRANSITIONS IN PROFESSIONAL NURSING

3 credits

Be introduced to the knowledge, skills, attitudes, theory and roles of contemporary and future professional nursing practice. Demonstrate skills for success using a variety of learning opportunities including Chamberlain success resources.

HOW DO I GET IN?

ELIGIBILITY REQUIREMENTS FOR JUMP-START RN TO BSN DUAL ENROLLMENT GRANT PROGRAM:

- Proof of English language proficiency
- Proof of enrollment in a participating community college or diploma nursing program within six months from application date
- Student must not have their ADN degree or diploma conferred prior to the original intended start date of the Jump-Start RN to BSN Grant Program
- Registration* as a new or readmitted student starting in the May, July, September or November 2020 session; additional options for 2021 sessions also

HOW MUCH WILL IT COST?

- Chamberlain's Jump-Start RN to BSN Dual Enrollment Grant Program will cover 100 percent of costs related to tuition, course resource fees and student services charges for NR-305: Health Assessment for the Practicing RN and NR-351: Transitions in Professional Nursing
- A total savings of up to \$4,600
- Books, ebooks or any other optional expenses will be the responsibility of the grant recipient
