Federal Pell Grant Gift Aid: does not have to be repaid	For undergraduates with exceptional financial need who have not earned bachelor's or professional degrees.	Amounts change annually. The maximum award amount for the 2021-22 academic year is \$6,495. Apply through fafsa.gov .
Federal Supplemental Educational Opportunity Grant (FSEOG) Gift Aid: does not have to be repaid	For undergraduates with exceptional financial need.	Maximum \$400 for the 2021-22 academic year Apply through fafsa.gov .
Iraq Afghanistan Service Grant Gift Aid: does not have to be repaid	For student who are not Pell-eligible due only to having less financial need than is required to receive Pell funds; whose parent or guardian died as a result of military service in Iraq or Afghanistan after the events of 9/11.	Equal to the amount of a maximum Federal Pell Grant for the award year, not to exceed a student's cost of attendance for that award year. Apply through fafsa.gov .
Federal Work-Study Self-Help Aid: money is earned; does not have to be repaid	For undergraduate and graduate students; part-time jobs can be on campus or of campus. Money is earned while attending school.	Maximum \$3,296 for the 2021-22 academic year. Apply through fafsa.gov .
Federal Direct Subsidized Loan Self-Help Aid: must be repaid with interest	For undergraduate students who have financial need; U.S. Department of Education generally pays interest while the student is in school and during certain other periods; student must be at least half-time.	Up to \$4,500 depending on grade level. Apply through fafsa.gov .
Federal Direct Unsubsidized Loan Self-Help Aid: must be repaid with interest	For undergraduate and graduate or professional students; borrower is responsible for all interest; student must be at least half-time; financial need is not required.	Up to \$10,500 depending on grade level and dependency status. Apply through fafsa.gov .
Federal Direct PLUS Loan Self-Help Aid: must be repaid with interest	For parents of dependent undergraduate students and for graduate or professional students; borrower is responsible for all interest; student must be enrolled at least half-time; financial need is not required; borrower must not have an adverse credit history.	Up to annual cost of attendance, minus any other financial aid received. Apply through fafsa.gov .
A+ Scholarship Program Gift Aid: does not have to be repaid	Provides scholarship funds to eligible graduates of A+ designated high schools who attend a participating institution.	Award amounts vary. For more information, visit http://dhe.mo.gov/ppc/grants/
Access Missouri Financial Assistance Program Gift Aid: does not have to be repaid	A need-based program for undergraduates; financial eligibility is determined by a student's Expected Family Contribution (EFC).	For more information, visit http://dhe.mo.gov/ppc/grants/
Bright Flight Program Gift Aid: does not have to be repaid	A merit-based program that encourages top-ranked high school seniors to attend Missouri post-secondary schools.	For more information, visit http://dhe.mo.gov/ppc/grants/
Kids' Chance Scholarship Program Gift Aid: does not have to be repaid	For children of workers who were seriously injured or died in a work-related accident covered and compensated by worker's compensation.	For more information, visit http://dhe.mo.gov/ppc/grants/

Marguerite Ross Barnett Memorial Scholarship Gift Aid: does not have to be repaid	A need-based scholarship for students employed while attending school part-time.	For more information, visit http://dhe.mo.gov/ppc/grants/
Minority and Underrepresented Environmental Literacy Program Gift Aid: does not have to be repaid	Designed to assist academically talented minority and underrepresented individuals pursuing a bachelor's/master's degree in an environmental course of study that will lead to employment in a field that is clearly environmentally related. Public Safety Officer or Employee's Child Survivor Grant Gift Aid: does not have to be repaid	Provides tuition assistance to certain public employees and their families if they employee is killed or permanently and totally disabled in the line of duty. Wartime Veteran's Survivors Grant Gift Aid: does not have to be repaid	Available annually to children/spouses of Veterans whose deaths or injuries were: a result of combat action or attributed to an illness contracted while serving in combat action, or who became 80% disabled as a result of injuries sustained in combat action since 9/11/01. NCMC Board of Trustees Scholarship Gift Aid: does not have to be repaid	Merit-based scholarship open to high school seniors or those who have graduated within the last year; minimum 3.75 high school GPA OR ACT composite score of 24 or higher.	\$600/semester, renewable for three additional semesters.
Missouri Boys State and Missouri Girls State Scholarships Gift Aid: does not have to be repaid	Granted to two high school seniors in each category who have attended Missouri Boys and Girls State.	\$250/semester, renewable for one semester.
Health Professional Nursing Student Loans Gift Aid: does not have to be repaid, unless student fails to carry out service obligation	For students pursuing careers as licensed practical nurses (LPN) or professional nurses (ADN) in underserved areas of Missouri.	Maximum \$5,000 depending on LPN or ADN.
E2 Education Empowers Scholarship Gift Aid: does not have to be repaid	Awarded to an incoming full-time, first-year NCMC student residing within NCMC's 16-county service region.	\$600/semester, renewable for three additional semester.
NCMC Foundation Scholarships Gift Aid: does not have to be repaid	Available to all NCMC students provided through the generosity of NCMC alumni and supporters of the College.	Award amounts vary.
